- Organized and attended Council work session on Thrive Montgomery 2050 and "Missing Middle Housing." Scheduled Town testimony on both matters.
- Researched professional assistance for Zimmerman Park improvements.
- Researched and disseminated guidance on the distribution and use of ARPA relief funds.
- Coordinated development of amicus brief related to PEPCO's current rate case filing.
- Renewed and rebid Town service contracts.
- Renewed Town insurance policies and position bonds.
- Oversaw Town road milling and repaving operations.
