## Public Hearing on Proposed Building Ordinance Amendments

At its **Wednesday, November 9** meeting, the Town Council will hold a public hearing on proposed amendments to the Town's Building Ordinance as recommended by the Town's Land Use Committee. The proposed changes to the ordinance are intended to relax some permitting requirements, to allow accommodations for accessibility by disabled persons, to codify existing practices and to clarify some existing provisions.

A summary of the proposed changes to the building ordinance appears on page 6. The full text of the proposed amended ordinance is posted on the Town's website.

## Council Approves Policy and Funding for New Street Light Requests

The Town Council has approved a policy for considering requests for new street lights. The policy and a "Street Light Report/Request Form," which residents can use to report problems with existing street lights or to request new street lights, are posted on the Town's website and available in the Town Office.

The Town's Public Services Committee (PSC) proposed the policy, which outlines who may make requests for new street lights and how those requests are processed by Town staff and considered by the Town Council. At its September meeting, the Council agreed with the PSC's proposal to move forward with installing new lights primarily in locations identified as dark areas by the recent street light evaluation study. At its October meeting, the Council held a public hearing on the proposed policy and approved a budget of \$20,000 for new street lights for this fiscal year. This amount will allow the Town to purchase and install approximately 13 new street lights over the next 8 months.

Residents are encouraged to use the Street Light Report/Request Form to help the Town identify problems with existing street lights as well as dark areas in Town where new street lights are needed.

# Greetings from the Mayor

As most of you are aware, the Town has experienced a number of burglaries in recent weeks. Like you, I am concerned about this trend and want to share some information and advice.

In response to these crimes, and in an effort to prevent further crime, the Town is coordinating closely with the Montgomery County Police Department (MCPD). We understand that police department detectives have identified some probable suspects and have issued warrants for their arrest. Police are actively seeking these individuals.

In addition to deploying marked patrol cars in Town to supplement the off-duty officers employed by the Town, the MCPD has utilized K-9 patrols and helicopters to assist in searching for possible suspects. The MCPD also is employing certain "high alert" activities to thwart crime and has involved its forensics team to investigate residential burglaries where physical evidence has been left at the scene. According to police reports, the recent crimes are not limited to the Town. In fact, many communities that surround us have experienced higher incidents of crime in recent weeks.

The Town's Neighborhood Watch Program seeks to reduce crime in our community by educating and organizing residents to report and identify suspicious activity in our neighborhood. The program continues to seek volunteers. My hope is that we will see a quick end to this recent spate of crime in and around Town and an equally quick return to a sense of safety.



### **Thanksgiving Holiday Food Basket Program**

Last year, we provided 75 Montgomery County Public School families with a wonderful Thanksgiving meal. Our families are identified through the County's Linkages to Learning program. These are families with very limited resources, which face difficult challenges as to how to provide enough food for their table. With 1 in 6 children under 18 in Montgomery County at risk of hunger, we hope to double the number of children and families we can help this year.

Here's how you can help between **November 1 and November 20**:

## Purple Line Update and Report

In early October, Governor O'Malley announced that Maryland has received approval from the Federal Transit Administration (FTA) to begin preliminary engineering on the Purple Line light rail project. This approval is an important first step in the State's quest to receive 50 percent of the project's total funding from the federal New Starts program. At the completion of preliminary engineering, the FTA will review the project again and decide if it will be accepted into final engineering. The State's most optimistic project schedule has the State receiving federal permission to move into final design in the summer of 2013, to start construction in 2015 and begin operation of the Purple Line in 2020. Being accepted into preliminary engineering, however, does not guarantee full acceptance into the New Starts program.

Immediately after the Purple Line announcement by the Governor, the State received news that the Obama administration is asking the FTA to expedite the review and processing of the Red Line light rail project in Baltimore along with 14 other projects across the country (the Purple Line not being one). Governor O'Malley has always said he wanted both the Red Line and the Purple Line to move in tandem, but, with the Obama announcement, that can no longer be the case. It is still unclear what this means for the Purple Line, especially as the State has yet to show exactly how it will fund any federal transportation matches.

The State is holding a series of Open Houses on the current status of the Purple Line, the nearest one to Chevy Chase will be held at the National 4-H Center on **Wednesday, November 2** from 5:30 to 8:30 p.m. Town residents are encouraged to attend to learn more about the project.

Meanwhile, the Town's Purple Line Mitigation Advisory Group (MAG) will continue to work with the Maryland Transit Administration (MTA) to minimize noise, visual and safety impacts of the project on our community if the Purple Line is built. At MAG's urging, the State recently completed measurements of ambient noise levels at residences near the Purple Line's planned route. MAG had successfully argued that the State's original noise studies at East West Highway did not represent noise levels in the Town's quiet neighborhoods and thus were not accurate when assessing mitigation needs.

Preliminary analysis of the newest noise studies confirms that current ambient noise in the Town is quieter than MTA had thought. Using FTA guidelines for transit noise and vibration assessment, MTA has determined that sounds from the Purple Line project will result in a "moderate impact" (at the high end of FTA's definition of "moderate") on our Town. MAG is working with MTA to ensure the impact of this noise is mitigated for residents throughout the Town.

This winter, the Town will ask MTA to present a demonstration of expected noise impacts from the Purple Line project to Town residents and to specify ways these impacts can be mitigated. ## Connecticut Avenue Corridor Committee

The County Council has delayed the **Chevy Chase Lake Sector Plan** process for several months. The Council took this action at the request of Chevy Chase Land Company, which recently hired new staff and formally announced they were hitting the "reset" button on their proposal for development at the site. As previously reported in the Forecast, the Land Company had originally proposed a development of 4.3 million square feet at the site with several buildings between 15 and 19 stories tall. They now say that proposal is off the table. In contrast, the County's Planning Staff released an outline for the area that called for 1.2 million square feet of development capped at approximately 6.5 stories tall.

Members of the Connecticut Avenue Corridor Committee (CACC), of which the Town is one, have agreed to meet with the Land Company to see if there are ways the group can help shape the Land Company's new plans. While members of CACC are very much in favor of the Planning Staff's recommendations, keeping with area residents' concerns. The Town's Long Range Planning Committee will be vetting the there is hope that a dialogue with the Land Company can produce a Land Company vision that is more in suggestions made by these discussions and will keep the community apprised of any developments.

## Proposed Amendments to the Building Ordinance

### Public Hearing on November 9

- The proposed ordinance would allow for the construction of access ramps for disabled persons and wheelchair lifts within a property's building setbacks. The existing building code does not regulate ramps and lifts, so a resident currently must obtain a variance to build these structures within a setback. This process can be costly and time-consuming.
- The requirement to obtain a boundary survey and an established building line survey for certain front porch coverings is proposed to be waived if an applicant has another reliable survey that shows the house is at least 25' from the front lot line. This change would reduce the financial burden of obtaining costly surveys for these smaller projects.
- The proposed ordinance clarifies an existing regulation that allows certain additions to be constructed onto houses that do not conform to current setbacks. The amendment explains that for certain additions, the side setback is to be measured from the location of the addition rather than from the existing non-conforming house. This provision makes it easier for residents to add on to existing, older homes.
- New provisions would be added to codify the Town's existing practice of allowing guardrails and handrails for safety. Under the current code, it is unclear whether these structures should be subject to the zoning restrictions for fences. This proposed change follows the County approach.
- The proposed ordinance clarifies how wall planes are measured to satisfy the offset requirement for front-loading garages. The current building code requires front-loading garages to be offset from walls on either side by 3 feet. The proposed amendment clarifies that this offset must extend from the finished grade to the roofline.
- The portion of the building code regarding structures, fences, walls, hedges, berms, etc., on private property has been reorganized and revised to make it easier to follow and to clarify some provisions.
- A new restriction prohibiting the construction of a wall or berm more than one-foot high within two feet of a side or rear property line is proposed.
- Finally, new definitions have been added to support the new provisions and amendments.

Residents are encouraged to attend the **November 9** public hearing. The Council meeting will begin at 7 p.m. in the Town Hall. During the recent infrastructure improvements, the Town did not mill and overlay some sections of streets in anticipation of the storm drain project. These streets will be repaired after the completion of the project.

- Put indoor lights on timers when not home.
- Use outdoor lights to eliminate hiding spots near entry points.
- Always lock car doors and close windows.
- Do not leave electronic devices visible in cars.
