Council To Discuss Generator Purchase

At its **February 13** meeting, the Town Council will host a public discussion on the possible purchase of a generator to provide backup power to the Town Office and Town Hall.

In response to several prolonged power outages resulting from recent storms, the Council asked Town staff to look into purchasing a generator. A generator may allow the Town office to remain open during outages and would offer a refuge for Town residents during times of weather extremes. The cost of a generator to provide backup power to both the Town Office and Town Hall would be approximately \$122,000.

The Council would like to hear your thoughts about the Town's possible purchase of a generator. If you cannot attend the February 13 meeting, you may send your thoughts in writing to the Town office at townoffice@townofchevyCHASE.org. Before any final decision is made, the Council will hold a public hearing, which will be advertised in the Forecast newsletter

Landscaping and Hazardous Tree Update

The Town will undertake right-of-way landscaping over the next several months. Trees that are ten inches or less in diameter will be edged and mulched. Stump grinding and sod repair will occur in mid to late March or when grass begins to grow in order to reduce erosion.

Also, the Town will remove trees in the right of way that have been identified as hazardous in a recent tree survey. Before work begins "No Parking" signs will be posted. The Maple Hill Townhome Community is a new construction project on Emory Grove Road in Gaithersburg, MD. Habitat for Humanity Montgomery County will build 19 townhomes on 2.9 acres of land. Each townhouse will have 3 bedrooms and 2.5 bathrooms with a garage on the first level. All homes will be sold to applicants earning less than 60% of the Area Median Income. In total, the project will cost about \$4.8 million, or approximately \$250,000 per unit.

CRIMEWATCH

No crimes were reported to the Town Office in January.

Update from Montgomery County Police

From time to time Montgomery County police forward reports to Town staff and our Neighborhood Watch Coordinators to keep the community apprised of crime-related issues. Most recently, Captain David Falcinelli in District 2 forwarded an update alerting the community that crime has been significantly reduced over the past year. Specifically, residential burglaries were down 40%, commercial burglaries down 17%, thefts from autos down 23%, and stolen vehicles down 40% over the past year. Because officers cannot be everywhere at once, these figures are reflective of your awareness and prudence in reporting suspicious activity.

Although property crime was down in 2012, crimes against persons increased from 42 to 57 occurrences, a 35% increase from last year. The report relayed that these occurrences receive Montgomery County Police's utmost attention and resources to deter future events and hold suspects accountable for their actions.

Montgomery County Police's Traffic Unit, along with our patrol officers, continues to aggressively enforce traffic violations and respond to neighborhood complaints. In 2012, 2nd District officers issued over 20,000 traffic citations. They are employing tag reader technology, which is allowing officers to identify suspended/revoked drivers and remove them from the road, in addition to recovering stolen vehicles/tags.

Residents are the eyes and ears of the community. Please report suspicious activity, persons, and vehicles immediately. In addition, residents are encouraged to get to know their neighbors and exchange contact information. Residents should also get to know their Neighborhood Watch block captains and discuss any areas of concern they may have. Chevy Chase Lake Sector Plan Update

The Planning Board has completed its review of the Chevy Chase Lake Sector Plan and will be sending its Plan to the County Council for final review and approval. Unfortunately, the Board clearly did not share the 'vision' of Planning staff and the neighboring resident groups for a modest increase in height and density for redevelopment. The Connecticut Avenue Corridor Committee, of which the Town is a member, was successful, however, in getting Board support for two sectional map amendments which legally assure less overall development prior to the Purple Line.

Phase I is now restricted to 750,000 square feet of mixed use development at the shopping center site (the current grocery store and T.W. Perry site), 750,000 square feet of density at Howard Hughes (which currently has no plans for development), and a modest increase at the Newdale Mews site. Unfortunately, the Planning Board also approved some building heights up to 150 feet on the shopping center site which the Corridor Committee strongly opposed. Two of the five Board members sided more closely with resident groups and have written a dissenting letter stating their objections to several of the final Board recommendations.

We want to thank the many Town residents who voiced their concerns to the Planning Board. The County Council will be taking up their review of the Plan in early Spring, and there will be an opportunity to submit comments. State Transit Officials to Brief Town Residents
on Purple Line Noise Abatement and Lynn Drive Crossing
Wednesday, February 27, 7 p.m., Town Hall

Town residents can learn about State plans to mitigate noise expected to be generated by the Purple Line transit project at a special meeting with Maryland Transit Administration (MTA) officials on [Wednesday, February 27, at 7 p.m.](#) in the Town Hall.

MTA engineers will demonstrate and discuss projected Purple Line noise levels before and after planned mitigation measures. They will talk about the noise-dampening measures they could use. In addition, MTA will discuss the various options it is considering to provide a safe pedestrian crossing at Lynn Drive, which the Town has urged.

The February 27 meeting has been organized by the Town's Purple Line Mitigation Advisory Group (MAG), which has worked with Maryland transit officials since late 2009 to minimize the negative impact of the proposed project on the Town. Noise reduction, visual impacts and safety concerns have been MAG's top priorities in working with the State.

Preliminary engineering on the Purple Line project is expected to be completed in the summer of 2013, and the State hopes for federal approvals and completion of the Final Environmental Impact Statement (FEIS) later this summer. MTA has sufficient funds to complete the FEIS and begin final design and is exploring various ways to fund Maryland's remaining share of the \$2.2 billion project. No federal funds have yet been earmarked for the project.

If funding is secured, construction could begin as early as 2015, and transit operations could begin by 2020.

Tree Tip of the Month

Tending to your green portfolio. For many of us in the Town, beautiful old shade trees define our sense of place. Just one look at what the Town looked like in 1920 shows how much harsher and sterile our Town would look without its beautiful tree canopy. In addition to giving our Town an essential part of its character, trees provide real value to each family including:

- Storm water removal by increasing filtration, absorbing water, and preventing erosion. By doing so, trees prevent contaminants from entering our water supply and the Chesapeake Bay.
- Enhancing property value (10-20%); the larger the tree, the greater the enhancement.
- Reducing energy use. In summer, shade trees reduce the heat absorbed by and stored in buildings reducing electric bills by as much as half, cool the air through evapotranspiration, and slow winds.
- Improving air quality. Trees absorb pollutants, intercept particulate matter, release oxygen, lower air temperature, and indirectly (by shading houses) reduce power plant emissions.
- Absorbing CO₂, the chief culprit in climate change.
- Serving as a sound barrier and privacy screen.
- Supporting the chain of wildlife that is vital to our health. Native trees support butterflies, birds, insects, and higher animals that keep our environment in balance.
- According to recent research trees, more than any other "green amenity," provide health benefits across the life cycle, reduce urban crime, enhance attention span, reduce stress, and bring people together.

Counting just the financial benefits, one 45-inch diameter southern red oak provides close to \$300 of benefits each year. With so many financial and intrinsic benefits, it makes sense to take as much care of your trees as of your financial portfolio.
