

## Life, Liberty & the Pursuit of Happiness...for All

In a few days, we will celebrate the 244<sup>th</sup> anniversary of the signing of the Declaration of Independence. Even though we cannot enjoy our traditional parade and barbecue together this year, the Community Relations Committee has pulled together a great July 4<sup>th</sup> celebration for us to enjoy (see page 3).

Independence Day is also a time to reflect on this country's founding and what it means for all of us. As we read the Declaration of Independence, we are reminded of the magnitude of injustice and indignities the colonists faced. In response, they created a new country with the promise that we are all created equal and entitled to life, liberty, and the pursuit of happiness. This year we also celebrate 100 years since the ratification of the 19<sup>th</sup> Amendment, enshrining women's suffrage in the Constitution.

But July 4, 2020 also will mark 40 days since George Floyd was murdered, 33 days since peaceful protestors were forcibly removed from Lafayette Square, and 5 years and 76 days since Freddie Gray died. Sadly, there are too many tragic anniversaries of violence and hate to list here.

In light of recent events, there has been an unprecedented call for a response at every level of government. We must continue to fight inequality and prejudice in all their nefarious forms, and we must find ways to heal and bring our community together, not just here in the Town, but more broadly. To do that, we will need open dialogue about both the assets and the flaws in our society. To further this effort, the Town Council unanimously agreed at our June 10 Council meeting to establish a Special Committee that will organize programs on social justice and consider other measures that we may want to pursue. I encourage interested residents, including teens and young adults, to volunteer for this new special committee.

Our civic engagement is one of our strengths, and I am grateful to all who have contributed their time and energy to making our Town a better place. I would particularly like to thank the chairs and members of our committees for all of their work. As noted above, the Community Relations Committee under the leadership of **Wicca Davidson** has refused to be stopped by a pandemic, finding ways to foster community and help others before and after COVID-19 arrived. Led by **Irene Lane**, the Climate & Environment Committee has worked to strengthen our recycling program, improve noise pollution and more. The Land Use Committee, chaired by **Lees Hartman**, continued efforts to streamline our building code while also guiding the Council through possible improvements to Zimmerman Park. With **Dedun Ingram** at the helm, the Long-Range Planning Committee has monitored development plans in Bethesda and pending policy changes at the County level. And the Public Services Committee, led by **Dave Eason**, analyzed options for improving permit parking and prepared us for the Town-wide traffic study that is currently underway. After years of service to the Town, Dave is now enjoying a well-earned retirement out of state, and we will miss him dearly.

As Independence Day approaches, please take a few minutes to think about how you as an individual, and we as a Town, can build on the promise from so long ago. Thank you, and happy 4<sup>th</sup> of July!

## July Public Hearing & Special Public Comment Period

### Public Hearing on Phased-In Restrictions of Gas-Powered Leaf Blowers

At its July 8 meeting, the Town Council will hold a public hearing on an ordinance to implement phased-in restrictions on the use of gas-powered leaf blowers in Town.

In May, the Town's Climate and Environment Committee (CEC) presented a report to the Town Council requesting action to address noise, harmful pollutants, and other impacts from gas-powered leaf blowers on landscape workers and residents. In response to the Committee's specific request for a phased-in ban, the Council asked the Town attorney to draft an ordinance to prohibit the use of gas-powered leaf blowers on Sundays, effective September 1, 2020, and to prohibit the use of gas-powered leaf blowers on weekends and federal holidays, effective January 1, 2021. The Council amended and introduced the ordinance at its June 10 Council meeting. The amendment stipulates that no fines will be imposed by the Town for violations of the new regulations prior to January 1, 2022.

### Special Public Comment Period on Total Ban of Gas-Powered Leaf Blowers

At its July 8 meeting, the Town Council will hold a special public comment period to solicit community feedback on the Climate and Environment Committee's proposal to implement a total ban of a gas-powered leaf blowers effective January 1, 2022. The Council will consider all public comments before deciding whether and how to proceed with a proposed ordinance, which would be subject to a future public hearing. ## Seeking Volunteers to Serve on Two Special Committees

The Town is seeking volunteers to serve on a special subcommittee to address regional growth and a special committee to address social justice issues.

The regional growth subcommittee will address important issues about land use, development, and public infrastructure. It will help develop a coordinated response to the County's updates to its General Plan (now called Thrive Montgomery 2050) and its Subdivision Staging Policy (now called County Growth Policy 2020-2024). Members of the subcommittee will research and monitor the issues raised in the Growth Policy and General Plan and will advise the Council.

The social justice committee will coordinate with the Community Relations Committee to organize programs and initiatives on race, racism and social justice; consider other measures that the Town may want to pursue to address these issues; and make recommendations to the Town Council.
