Public Hearings Scheduled for December Council Meeting

The following public hearings are scheduled for the December 8 Town Council meeting. If you are unable to attend the Council meeting, which begins at 7 p.m. via Zoom video conference, you may submit comments to townoffice@townofchevy Chase.org. See the Town website for more information.

Zimmerman Park Redevelopment

On December 8, the Council will hold a public hearing on redevelopment plans for Zimmerman Park. In November, the Town held a walking tour of the park for Town residents to understand and discuss the extent and location of the proposed improvements, and the Town held a public forum on November 29 to answer residents' questions and receive resident feedback about the planned improvements. Another walking tour will be held on December 4 at 1 p.m. before the Council holds a public hearing and decides how to proceed with the redevelopment plans at its December 8 meeting. Speed Hump on Maple Avenue Between Aspen Street & Blackthorn Street

On December 8, the Town Council will hold a public hearing on the installation of a speed hump on Maple Avenue between Aspen Street and Blackthorn Street. At the request of the Town Council, the Town performed a traffic speed and volume study on this block of Maple Avenue, and the results meet the Town's qualifying thresholds for a speed hump. The Town's traffic engineer has reviewed the road alignment and found that there is an appropriate location for a hump to be installed in that block.

Public Forum on Lowering Town Voting Age

On December 8 at 5:30 p.m., the Town Council will hold a public forum to discuss and hear from residents about a proposal to lower the voting age to 16 for residents who wish to participate in Town elections. The Council held a public forum on this proposal on October 25 and discussed the proposal at its November 10 meeting. Following the December 8 public forum, the Council will decide at its regular meeting that same evening whether to introduce a resolution to implement this change. If the Council introduces the resolution, a public hearing will be scheduled at the January 12 Council meeting.

Public Services Committee Notes

Traffic & Safety -- Be a good neighbor and follow the Town's motor vehicle, traffic, and parking laws. They are there to protect motorist and pedestrians. In addition to the Town's ordinances, all motor vehicle laws, ordinances and regulations of the state and county are in effect in the Town. Now that traffic is beginning to return to pre-pandemic levels, the Town has asked police to step up traffic and parking enforcement. Please be aware of the following:

- The Town speed limit is 20 mph, unless otherwise posted.
- Stop for pedestrians in crosswalks and intersections.
- Stop at stop signs and for school buses.
- Expect bicyclists on the road and allow at least three feet when passing.
- Do not block sidewalks, driveways, or fire hydrants.
- It is unlawful to park on the opposite side of the street with left wheels to curb unless it's a one-way street.
- All vehicles within a permit parking area must display a valid permit parking decal or guest pass. Contact the Town office at 301-654-7144 to request a permit parking sticker if you live in a designated area.

5G Working Group -- The Committee has established a 5G Working Group to follow the implementation by service providers of 5G cellular service in the Town and to advise the Town Council on any changes that may be needed to the Town's ordinance on small telecommunications wireless facilities. We are looking for volunteers with technical telecommunications or spectrum management expertise to help the Working Group. Climate & Environment Tip of the Month

“The Issue with Tissue”

Americans' love of luxury paper products is harming the environment. In the 90 seconds it will take you to read this message, two football field-sized areas of the Canadian boreal forest will have disappeared. What are boreal forests and why should we care? Boreal forests are full of deciduous trees and conifers and cover vast expanses in Canada, Alaska, and Russia. They're an important carbon sink which absorbs carbon dioxide -- a main contributor to global warming and climate change and they're home to abundant wildlife.

But these crucial forests are threatened, due in large part to the demand for virgin pulp to make ultra-soft TOILET PAPER, FACIAL TISSUE, PAPER NAPKINS AND PAPER TOWELS.

Fortunately, there are eco-friendly alternatives:

- Look for recycled and chlorine-free paper products or products made from Forest Stewardship Council-certified bamboo. These are available in local stores and online. Recycled paper products (don't worry -- not made from used toilet paper or Kleenex!) are almost as soft and strong as the “luxury brands” -- and without the negative effect on the environment.
- Use cloth rags, sponges, and dishcloths instead of paper towels whenever possible. Skoy cloths are an example of an effective, washable, and compostable cleaning cloth.
